AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, SECTION 1-4 OF ARTICLE I, CHAPTER 1 OF THE PUBLIC LOCAL LAWS OF KENT COUNTY, (BEING ARTICLE 15 OF THE CODE OF LOCAL LAWS OF MARYLAND) TITLE "COUNTY COMMISSIONERS", SUBTITLE "LEGISLATIVE SESSIONS" TO CHANGE MONTHLY LEGISLATIVE SESSION DAYS TO THE FIRST AND THIRD TUESDAYS OF EACH MONTH.

Emergency Bill No. 4-94

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, PROVISION 16 OF 10.2 OF SECTION 10A OF ARTICLE V OF THE ZONING ORDINANCE FOR KENT COUNTY, MARYLAND, PROVIDING FOR MORE THAN ONE INTRA-FAMILY TRANSFER PER EXISTING PROPERTY IN AN INDUSTRIAL DISTRICT UNDER CERTAIN TERMS AND CONDITIONS.
