**CHARTER AMENDMENT TO ARTICLE XII, SECTIONS FC12-1 THROUGH FC12-7 DEALING WITH PURCHASING**

A RESOLUTION TO AMEND ARTICLE XII, SECTIONS FC12-1 THROUGH FC12-7 OF THE FRUITLAND CITY CHARTER, ENTITLED PURCHASING, CONTRACTS AND SURPLUS PROPERTY, BY REPEALING ARTICLE XII, SECTIONS FC12-1 THROUGH FC12-7 AND REPLACING THEM WITH A NEW ARTICLE XII. THE PURPOSE OF THIS AMENDMENT IS TO ADD CONTRACTS FOR SERVICES, SUBJECT TO EXISTING EXCEPTIONS, TO THOSE ITEMS COVERED BY THE ARTICLE AND TO ADD FLEXIBILITY TO THE PURCHASING POLICY BY RAISING FROM FIVE THOUSAND DOLLARS (\$5,000.00) TO FIFTEEN THOUSAND DOLLARS (\$15,000.00) THE THRESHOLD AT WHICH FORMAL BIDDING SHALL BE REQUIRED, STATING CRITERIA WHICH MAY BE CONSIDERED IN DETERMINING THAT A PARTICULAR PURCHASE MAY BE MADE WITHOUT FORMAL BIDDING EVEN IF ABOVE THAT AMOUNT, PERMITTING THE USE OF BID OR NEGOTIATED CONTRACTS WITH OTHER JURISDICTIONS TO REPLACE FORMAL BIDDING BY CITY AND SETTING FORTH PARAMETERS WITHIN WHICH CITY COUNCIL MAY, BY ORDINANCE, IMPLEMENT SUCH POLICY.
