HILL'S SUBDIVISION OF SHOWDEN'S NEW BIRMINGHAM MANOR" AND RECORDED AMONG THE SAID LAND RECORDS IN PLAT BOOK 8 PAGE 53; A PORTION OF LOTS 8, 9 AND 10 OF THE PLAT ENTITLED "NEW BIRMINGHAM MANOR RICHARD S.
